Purpose and Summary: MDHA has prepared for submittal to the U.S. Department of Housing and Urban Development (HUD) the 2015-2016 Annual Update to the 2013-2018 Consolidated Plan for Housing and Community Development (2015 Action Plan). The 2015 Action Plan describes community needs and funding priorities for the 2015-2016 program year (April 1, 2015 through March 31, 2016) and serves as Metropolitan Nashville-Davidson County's application for receiving funds for the following programs: Community Development Block Grant (CDBG), HOME Investment Partnerships Program (HOME), the Emergency Solutions Grant (ESG), and Housing Opportunities for Persons with AIDS (HOPWA). Proposed funding allocations are intended to address the priority needs identified in the 2013-2018 Consolidated Plan and to benefit low- and moderate-income households and areas. Details regarding specific activities to be funded are provided in the 2015 Action Plan.

Funding Priorities:

- Increase the supply of affordable housing
- Strengthen collaboration among network of service providers
- Increase access to healthy food choices
- Decrease homelessness
- Develop and implement place-based strategies for community development
- Provide summer programs for low- and moderate-income children and youth
- Provide housing assistance for persons with HIV/AIDS
- Affirmatively further fair housing
