

## **UPDATE on the Nashville-Davidson Continuum of Care Technical Assistance Process January 27, 2017**

HUD-funded consultants, the Cloudburst Group, returned to Nashville on January 12<sup>th</sup> and 13<sup>th</sup> for a second site visit. Cloudburst met with the Steering Committee from 9am – Noon, on Thursday, January 12. Stakeholders had the opportunity to observe this meeting. Notes from the Steering Committee meeting are attached. As Cloudburst mentioned at both the Steering Committee meeting and Community Meeting, slides about specific communities have been removed in deference to those jurisdictions.
