- Assists in the replacement or repair of door closures and a variety of locks;
- Installs window glass and screens;
- Paints and preps wood doors, cabinets and furniture;
- Installs and repairs floors and wall coverings;
- Installs and repairs ceramic and other varieties of tile;
- Does plaster work and drywall;
- Makes work sketches of doors, cabinetry and counters;
- Installs and repairs plumbing and electrical systems related to kitchen and bathroom installations;
- estimates materials and time needed for jobs;
