Lead position for coordinating implementation activities and performance measures across the partner network. Performs related duties as required.

 - Coordinates the creation and tracking of performance measures for People Plan implementation activities across the partner network
 - Assists in scheduling and marketing of on-site services provided by partners 0
 - Attends and participates in community meetings and civic programs 0
 - Collaborates with MDHA grant writers and partner network members on joint funding opportunities
 - Execute MDHA programing related to People Plan implementation, such as MDHA's ConnectHome Napier & Sudekum program, as directed Collaborates with MDHA grant writers on MDHA-specific funding opportunities
 - Assists in securing additional community resources and supportive services to benefit projects

- ability to deal tactfully yet respectfully with the public;
- knowledge of programs and activities relating to urban and community development, public housing, rental assistance, affordable housing, commercial revitalization, and the policies and procedures of MDHA;
