REQUIRED EDUCATION, EXPERIENCE AND LICENSES

Bachelor's degree in Architecture, Business, or a related field and four years of experience in building construction or inspection or a related field, or a two-year degree from a college or technical school and six years of experience in building construction or inspection or a related field. - inspects and reviews shop drawings;
- responsible for keeping new product information;
- inspects and provides for the correction of poor workmanship;
- inspects the work of various craftsmen to insure installation of building components in conformance with plans and specifications;
- makes daily progress reports;
- reviews contractor requests for payment; and assists in the final project inspection.

- Knowledge of construction principles as applied to the inspection of multi-level structures;
- knowledge of building construction materials, methods, and equipment; ability to read and understand engineering and architectural specifications and commercial standards;

- ability to establish and maintain effective working relationships with professional, technical, and craft workers; and willingness and mental and physical ability to perform the duties involved in this classification;
